The Committee reserves the right to substitute any judge who may not be able to officiate.

All exhibitors/handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries or damage which may arise or be caused by their dogs.

No dog shall be allowed to be off a lead or benching chain unless required by the Judge.

No animal other than an exhibit entered for competition or for exhibition only, shall be allowed within the precincts of a Show, except a registered Guide Dog for the Blind or hearing dog for the deaf or dog requested for educational or instructional purposes or by permission of the Show Committee of the Show -holding Club.
