Bitches	Bitches in season are allowed to compete. Please advise the trials manager in advance. Bitch to remain in car/trailer until judge authorizes otherwise. They will be judged after all other dogs have competed.
Draw Order	As per KUSA regulations, the order of competition will be determined by a draw among the competitors in each grade. Any competitor who is not present at the time of the draw may, at the discretion of the judge, not be permitted to compete.
