Bitches in season are allowed to compete in Breed, Agility and Dog Jumping only. All Exhibitors/Handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries caused by their dogs. The mating of bitches within the precincts of the Show is forbidden. Conditions attracting immediate disqualification are set out in Reg. 4.4 of Schedule 4 and Reg. 31 of Schedule 3. No animal other than an exhibit entered for competition or exhibition shall be allowed on the grounds, with the exception of registered guide dogs. The Committee reserves the right to appoint alternative Judges should any of the above be unable to officiate. No changes will be made at the Show. All exhibitors, handlers & owners are advised that they and any exhibit entered at this Show may be photographed for, by or on behalf of the organisers for the use and possible publication of such photograph by KUSA.
