**All dogs are to be on lead throughout the duration of the show. Bitches in season will be allowed to compete in Agility only, however STRICT rules will apply if not adhered to you will be asked to leave.**

**Please remember your dog's RECORD CARDS AND RABIES & VACCINATION RECORDS.**

Dogs under 14 months of age are not permitted to enter Dog Jumping and dogs under 18 months of age are not permitted to enter Agility.

All exhibitors/handlers are always personally responsible for the control of their dogs and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs. Conditions attracting immediate disqualification are set out in Regulations 7 & 31 of Schedule 3. Please refer to Schedule 3, Reg. 5 (this also applies to Qualifying/Re-Qualifying shows) & your own Discipline Regulations.

The show committee has the right to appoint alternative judge/s if any are unable to keep their appointments.
