Dogs under 14 months of age are not permitted to enter the show. All exhibitors/handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs. Conditions attracting immediate disqualification are set out in Regulations 31 of Schedule 3.
